**Instructions for the Scholarship Application**

- A. Student / Career Changer Eligibility:** In order for one to be eligible for a full ASCEND Conference Scholarship, all of the following qualifications must be met.
1. Is admitted to a university or college as a full-time student or is changing professions and does not have ASCEND Conference registration fees covered by their employer
  2. Demonstrates academic accomplishments; i.e., GPA and degrees received, as well as professional and community involvement
  3. Furnishes one letter of support from either a professor, instructor, or financial planning professional
  4. Furnishes a statement - not exceeding one-page - indicating reasons to be considered for a full ASCEND Conference Scholarship
  5. Furnishes a current resume
- B. Submission Information:**  
Applications must be received by **October 15th** Applications received after the deadline are not guaranteed review and resumes may not be made available to Conference attendees.  
Scholarships will be awarded no later than **October 19th**.
